ORDER:-

During the Collectors' Conference held from 11.12.2013 to 13.12.2013, among others the Hon'ble Chief Minister made an Announcement that "Investigation would be taken up for providing Combined Water Supply Scheme to 293 Rural Habitations in Musiri, Thuraiyur, Thathayangarpettai and Uppiliyapuram Unions of Tiruchirappalli District (Announcement .191)

2. The Managing Director, Tamil Nadu Water Supply and Drainage Board has informed that 293 Nos. of habitations in Musiri, Thathayangarpettai, Thuraiyur and Uppiliyapuram Unions in Tiruchirappalli District are to be provided with water supply, with River Cauvery as source. The details are as follows:-

This scheme will be implemented under 100% grant from MNP / NRDWP - SMS and on completion Tamil Nadu Water Supply and Drainage Board will maintain this Combined Water Supply Scheme. The cost per 1000 litres is Rs.27.93/-.

Based on the recommendation of Tamil Nadu Water Supply and Drainage Board in its Resolution No:2.11, dated:28.11.2014, the Empowered Committee has resolved to recommend to Government for according Administrative Approval to the proposal for providing Combined Water Supply Scheme to 293 Rural Habitations in Musiri, Thathayangarpettai,

Thuraiyur and Uppiliyapuram Unions in Tiruchirappalli District, with River Cauvery as source, at a cost of Rs.140.22 crore to install and Rs.2.50 crore to maintain annually, and to implement the Scheme with 100% Grant under MNP/NRDWP-SMS.

6. Accordingly the Managing Director, Tamil Nadu Water Supply and Drainage Board has sent proposals to Government to issue necessary orders to implement the above said scheme.

7. As recommended by the Empowered Committee and as requested by the Managing Director, Tamil Nadu Water Supply and Drainage Board the Government after careful consideration accord Administrative Sanction for providing Combined Water Supply Scheme to 293 Rural Habitations in Musiri, Thathayangarpettai, Thuraiyur and Uppiliyapuram Unions in Tiruchirappalli District, with River Cauvery as source, at a cost of Rs.140.22 crore (Rupees One hundred and Forty Crore twenty two lakh only) to install and Rs.2.50 crore (Rupees two crore fifty lakh only) to maintain annually, and to implement the Scheme with 100% Grant under MNP/NRDWP-SMS.




