I submit to state that, the providing Dedicated Water Supply Scheme to Usilampatti Municipality in Madurai District is under progress, based on the Administrative Sanction issued by the Tamilnadu Government vide letter 1st cited. As per the above proposal, the required water is proposed to tap the ultimate stage requirement of water 9.98 MLD of surface water from the upstream of the pick up weir in river Vaigai downstream of the Vaigai dam by providing intake well. Water from this intake well will be collected in collection well and pumped in to proposed Treatment plant located in AundipattiKanavai (Near ShaasthaKovil).

The proposed pumping main is routed through 0.13 ha of forest land. The proposal for permission was submitted to the Forest Department along with certificate issued by the District collector, Theni. In the reference 3rd cited, the DFO. Theni forest Division, Theni has informed to this office that the location for laying water supply pipe line falls under Aundipatty South reserved forest, but in the proposal and District Collector's certificate it has been mentioned that the location falls under Thimmarasanayakkanur North Reserve forest. Further, the DFO has requested this office to change their proposal and get the revised certificate from the District Collector, Theni. As per request of DFO Theni, a revised certificate was obtained from District

collector Theni on 02.11.2021. The revised certificate was uploaded in online and also modified the relevant documents.
