5. Industry shall develop green belt as per the Protocol attached with Board's office order H 16405

/220/2018/02 dated 16-2-2018, which is available on Board's website- www.uppcb.com.

6. Disaster Management Plan as per guide line of Chief Exclusive, Nagpur must be installed. License from Chief Exclusive, Nagpur for the installation and operation of the petrol pump must be obtained as required and submitted within two month.

7. Proper Safety Devices must be provided to the factory workers.

8. All the effective safety measures must be taken to avoid any contamination/deterioration in the surrounding environments/ecosystem.

9. The provisions/guidelines notified under the Environment (Protection) act 1986 (as amended) must be strictly complied.

10. NOC/ license/Consent of concerned departments for installation & operation of industry must be obtained and submitted this office within two months.

11. Housekeeping of the industry should be maintained properly.

12. Application for water and air consent must be applied before two month of expected trial production. Trial production must be started after obtaining the valid consent from the Board.
