- 1. Please refer your office letter cited at SI No. 8, wherein EDS has been raised to update the geo-reference maps as per site condition for Sirsi division. Accordingly, the geo-reference maps for Janmane and Sirsi range are revised and re-estimated forest area proposed to be diverted for the project, works out to be 32.925 Ha (Honnavara Division 19.199 Ha & Sirsi Division 13.7262Ha).

Since, it was not possible to update the forest area in PART-I of FORM-A online application, (as check box not available to edit the area), the revised documents and details are uploaded in additional information. Also, the hard copy of the forest clearance application alongwith KML files in CD is submitted for your kind perusal and further processing.
