## TO WHOMSOEVER IT MAY CONCERN

In Compliance of the ministry of Environment and Forests (MOEF) Government of India's letter No-11-9/98-FC(pt.) Dated 3<sup>rd</sup> August 2009 wherein the MoEF issued guideline on submission of evidences for having initiated and completed the process of settlement of right under the schedule tribes and other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 ('FRA' for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF letter dated 5<sup>th</sup> February wherein MoEF issued certain relaxation in respect of linear Projects, it is Certified that **53.2130 hectare** of forest land proposed to be diverted in favour of **Jharkhand Urja Sancharan Nigam Limited (JUSNL)** for Construction of 132kV D/C Hunterganj- Chatra Transmission line in CHATRA District falls within Jurisdiction of Beduali, Basaria, Tetaria, Kon, Kathun, Gobardih, Bakhardih, Bakain, Kanchan, Mongwadaha, Karailibar, Boura, Kangurwa, Karma, Bhogatadih, Kurid, Seldaha, in Hunterganj Block and Darha, Sikid, Mohnadih, Barisaram, Kuba, Sanghari, villages in Chatra Block.

It is further certified that

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire **53.2130 hectare** of forest area proposed for diversion. A copy of record of all consultations and meeting of the Forest Right Committee(s), Gram Sabha(s), Sub Divisional level committee(s) and the District Level Committee are enclosed as annexure I to annexure III.
- (b) The Diversion of forest land for facilities managed by the Government as Required Under section 3(2) of the FRA have been completed and the Gram sabhas have given their consent to it;
- (c) The Proposal does not involves recognized right Primitive Tribal Groups and Pre-agriculture communities.
