# Proposal for seeking of prior approval to construct 11 KV Distribution line through forest area in Rohtas District under wildlife Sanctuary area Proposed by South Bihar Power Distribution Company limited under taking by Bihar State Government.

- 1. Project Details:-Project taken under DDUGVY-11<sup>th</sup> Plan for village Electrification work for providing electricity to Fifteen thousand two hunderden thirteen (15213) rural households spread in 52 Villages and public places like Government Offices, health centers, Banks across the Nauhatta, Rohtas blocks of Rohtas District falls under Rohtas Wildlife Sanctuary area.
- We are constructing 11 KV distribution line in existing roads and paths using by villagers through forest area in Rohtas wildlife sanctuary. This alignment was very suitable (i,e only by existing forest roads) and minimizing the tree falling under above said line. Electrical Executive Engineer (Project) Rohtas is in constant touch with respected Divisional forest officer, Rohtas and follows his instruction very carefully while carrying out survey work. Total cost of the Project for Nauhatta, Rohtas Block under District Rohtas is 6.06 Crore. There is no displacement of people will likely to happen 2000 Temporary man days are likely to be created for execution for this project in Rohtas wildlife sanctuary.
- 3. In this project for erection of the 11 KV distribution lines to provide electricity to the population residing in Rohtas forest wild life sanctuary, Total required Poles an approximate 1200 Poles will be installed on the forest road flanks which are mostly used by villagers requiring aggregate area of 10.06 Hectare.
- 4. To avoid cutting of trees, we are using 11KV Aerial bunched cable in entire forest land so that we can construct the line by trimming the branches wherever required and requirement of land also will be minimized.
- 5. This line will be connected to existing 11 KV line which was started from the Samhoutha 33/11KV Substation. We are planning to tap this line new line at Taradih village and passing through forest land and splitting in two branches at Dhansa village and the details of branch lines are as follows.
