- In pursuance to Government of India EDS Query that any verification done by the Nodal
 Officer subsequent to 28-06-2022 cannot be taken on record. Therefore, this agenda was
 considered by the Project Screening Committee in the meeting held on 11-01-2023. The
 Nodal Officer (FCA) Karnataka, Member Secretary, CCF Belgaum, DCF Belgaum,
 Representative of DC Belgaum and the officials of User Agency attended the Meeting.

- 3. User Agency made a presentation on the project.
- 4. The User Agency stated that to avoid alternate Underground and Overhead Transmission Lines frequently all along the alignment as proposed earlier, now the Underground Transmission Lines will be up to Amate Village upto a length of 11 Km and then onwards it is realigned as Overhead Transmission lines to take it completely in non-forest land to a length of 30 Km. Thus, the total extent of forest area has been reduced from 33,0507 Ha to 26,9255 ha.
- Project Screening Committee went through the Project details and it was found to be in order as all the requirements were found to have been fulfilled.
- Hence, the project was accepted by the Project Screening Committee for further necessary action.
