With reference to the above, I wish to state that Online proposal for diversion of 0.1254 ha. of Forest Land for providing Combined water supply scheme to 8 Town Panchayats , 2452 Rural Habitations in 11 Unions with bulk provision to 3 Muncipalities in Sivagangai District has been submitted vide reference 1st cited and the remarks are communicated vide reference 3rd cited. Now the proposal is revised as follows.

 The proposed land for construction of foot bridge and MV panel room in 3 locations from 3 collector wells namely 1,2,3 comes under Rajendram reserve forest are revised instead of Rajendram north and Maruthur north reserve forest. 2. Secondly it was stated that the proposal location for construction of Foot Bridge and MV panel room for collector well 4&5 and location for construction of foot bridge, Collection sump, Baby sump, Control Room and Transformer yard lying in S.F.No.20 & 29 also belongs to reserve forest land reported by the DFO, Karur and requested to submit the revised proposal in the web portal. But for the above site necessary enter upon permission has been obtained from the District Collector, Karur on 30.09.2021 so these lands are in problematic situation.

In the meantime during visit of CCF, Dindukal at DFO office, Karur on 11.01.2022 the issue has been discussed. During the discussion, TWAD requested the CCF, Dindukal to attend the remarks of collector well 1, 2, 3 separately and upload immediately and for collector well 4, 5, and collection sump after finalizing the land issues by the government and it will be uploaded in the portal web in due course.

As per the instruction of CCF, Dindukal the remarks has been attended and now upload in the portal web for collector well no.1, 2, 3 only.
