

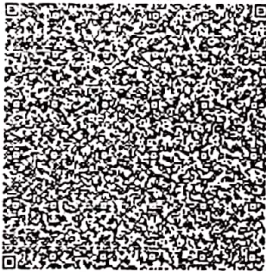

R. Ambedkar Veedi, Bengaluru-560001 (Hereinafter called the 'Employer') on one part and Shri. Sharfuddin Ali, (M/s Ocean Constructions India Pvt., Ltd.), Mangalore (hereinafter called the 'Contractor') on the other part.

Whereas, the Employer is desires that, the Contractor to execute the work of "Survey, Investigation, design, Supply, Installation, Testing and Commissioning of Lift Irrigation system ((Head Works consisting of Intake canal, Jack well cum pump house, Power supply including substations and Transmission lines, Rising Main and Delivery chamber etc) and Construction of Gravity Distribution System including structure for providing Drinking water and recharging ground water to fill 20 tanks coming under Shirahatti taluk Gadag District. including Operation and Maintenance for a period of 5 years after successful commissioning on Turn-Key Basis for SHIRAHATTI Lift Irrigation Scheme in Shirahatti taluk, Gadag District, Karnataka" (Indent No.22315)" hereinafter called the 'Work', and the Employer has accepted the bid by the Contractor for the execution and completion of such 'Work' and the remedying of any defects therein at a cost of Rs. 137,06,88,249.00 ( Rupees one hundred thirty seven crore six lakh eighty eight thousand two hundred and forty nine only)

2. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the works and remedy of any defects therein conformity in all aspects with the provisions of the contract.
3. The Employer hereby covenants to pay the contractor in consideration of the execution and completion of the works and remedying any defects to conformity in all aspects, wherein the contract price or such other sum as may become payable at the times and in the manner prescribed by the Contract.
