ORDER:

The Engineer-in-Chief, Rural Water Supply & Sanitation, Hyderabad in his letter 1st read above has submitted proposals for improving water quality in saline affected habitations under 13th Finance Commission Grant for the Years 2012-13 to 2014-15 for an estimated cost of Rs. 350.00 Crore for approval of High Level Committee and to accord administrative sanction at a time for 3 years 2012-13 to 2014-15 for the targeted 1202 saline affected habitations of 9 coastal Districts are proposed to cover with treated sustainable surface water through 47 Multi Village Schemes (MVS). The CE, NABARD, RWS&S, Hyderabad in his letter 2nd read above has submitted approved action plan under 13 Finance Commission grant for 3 years i.e., 2012-13 to 2014-15 approved by the High Level Committee (Project wise and list of habitations proposed under each project).

- The Government after careful examination of the request of the Engineerin-Chief, Rural Water Supply & Sanitation, Hyderabad hereby accord administrative sanction for an estimated cost of Rs.350.00 Crore (Rupees Three bundred and fifty Crore only) Part-A at a cost of Rs.14.10 Crore and Part-B at a cost of Rs.335.90 Crore for improving drinking water supply to saline affected habitations for 3 years from 2012-13 to 2014-15 as approved by the High level Committee under 13th Finance Commission grant, subject to release of the grants allotted in the particular year. The details of the sanctioned projects in Annexure-I, and list of habitations to be covered under the sanctioned projects are enclosed in Annexure-II.
- As and when the Engineer-in-Chief, RWS&S Department reports to Government that the PART-A components are completed and then the Part-B Component will be cleared by the Government for grounding after scrutiny of Part-A clearances.
- The Engineer-in-Chief, Rural Water Supply & Sanitation Department, Inderabad, is requested to limit the expenditure to Rs.350.00 Crore (Rupees Three hundred and fifty Crore only) and details of all works should be uploaded on MS "Watersoft" System.
- The Engineer-in-Chief, Rural water Supply and Sanitation Department, Independent of the second of t Commission grants and utilize the funds as per financial rules. No changes shall te made on ground without following due procedure.
- For any change from sanctioned technical estimates during execution, the agreement authority shall approach the approving authority concerned in writing. assumption of approval should be made unless approval is received in The Technical sanction to be accorded must fully conform to the above administrative sanction components only.

- The Engineer-in-Chief, Rural water Supply and Sanitation Department, Hyderabad, while conveying the technical approval/sanction should ensure that recessary instructions shall be incorporated therein to all the agreement authorities (SEs) to follow the sequential order i.e. head-to-tail approach scrupulously (i) in grounding works, and (ii) while sanctioning payments.
- The list of projects sanctioned and list of habitations to be covered under the sanctioned projects are annexed to this order in Annexure- I & II. No changes in coverage of projects and habitations shall be made without the approval of the Government.
- 9. All works based on surface water source will be taken up only after clearance from Irrigation Department or the owner of source, as the case may be.
- 10. The DPR properly approved by competitive authorities should be forwarded to the Government.
- 11. The per capital cost and other technical parameters should be informed to the Government.
- 12. The Reliability and sustainability of the source and technical parameters needs to be examined by the STA. The ENC, RWS&S Department shall examine the issue and report to the Government.
- 13. The Superintending Engineer, Rural Water Supply and Sanitation Dept., concerned shall place the work to a District Level Committee consisting of:

to expedite clearance in Part-A. Senior Officials of Forest Department and Railways may be called on a need basis.

- 14. The above Committee shall also ensure that the PRI concerned like ZP or GP is agreeable to take up the O&M of the Scheme from their funds on commissioning.
- 15. The Engineer-in-Chief, Rural Water Supply & Sanitation, Hyderabad is requested to scrupulously follow the guidelines of the schemes and utilize the funds as per prescribed financial rules and take necessary action accordingly.
- 16. This Order issues with the concurrence of Finance (FC.I) Deptt., vide their U.O.No. 27027/133/FC.I/2010, dated: 01-08-2012.
