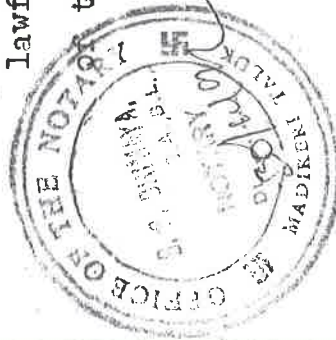

6. To compromise all suits, appeals, revision etc., sign the compromise petition, file the same before the concerned court or authority, admit execution thereof and do all needful.
7. To get the land surveyed, represent us before the survey department, sign all applications, petitions, mahazar etc., on our behalf as well.
8. To incur such expenses as are deemed necessary for the litigation. ~~XXXXXX~~
9. Our attorney shall be entitled to sell the entire tree growth of all sizes and species including its firewood to anyone he deems fit and appropriate the proceeds thereof towards the reimbursement of the expenses already incurred and to be incurred in future in defending the illegal claim over the timber in the schedule property laid by one Sri.A.K.Thammaiah. We are not entitled to ask for any account of the expenditure and the consideration received by way of sale price from the sale of trees from the schedule property.
10. Generally to do all lawful acts, deeds and things that are necessary to carry out the purpose of this power and we hereby agree to ratify and confirm all lawful adts, deeds and things done by our attorney by virtue of these presents.
