(iii)	Cost of the project	: The Government has accorded Administrative sanction for an amount of RS.205.03Crores for the subject project vides G.O.Ms No. 362,dt:09.11.2012 and accorded Revised Administrative sanction for amount of Rs.308.03 lakhs vide G.O.Rt.No.28, dt: 30.01.2019 A copy of the said GO is enclosed herewith for ready reference.
(iv)	Justification for locating the project in forest area	: The Government of Telangana State has decided for PWD Road to Neelavancha(km9/550 to 13/120) at GudurMandal of Mahabubabad District under PMGSY. The Govt. vide GO Rt.No.362, Panchayat Raj and Rural Development, under PMGSYProposals of 2012-13 ,dated.09.11.2012has approved administrative sanction and GO.Rt.No.28, Dt:30.01.2019 for Revised Administrative Sanction for laying of BT and maintenance of Roads. The proposed project is one among them. The existing surface is from km 9/550 to 10/900 is track portion and from 10/900 to 12/500 hillock portion and from 12/500 to 13/150 is track portion.The project is for New connectivity of the existing road from track to BT Standards. The road passes through the reserve forest km 9/550 to 12/ ³⁵⁰ 730 and from 12/ ³⁵⁰ 730 to 13/120 is village portion. Hence forest clearance is needed in the reach 9/550 to 12/ ³⁵⁰ 730 ie ²¹⁰⁰ 3180 mts for formation & up-gradation of road to BT standards. It is also an important road connecting these villages to the GudurMandal Headquarter enrouting number of interior villages, and also vehicular movement for transportation of goods. For the people of Neelavancha, No other transport is available except the proposed road which leads to Mandal

		<p>head quarters Gudur via Matwad Gram Panchayath. As per Govt. policy all habitations to be connected. There is no alternative land or route available to connect the habitation, hence the road is proposed through forest.</p> <p>As per the DGPS survey authentication report, the extent of area passing in the Reserve Forest area is <u>3.816</u> Ha. (Length - <u>3180.00</u> mts, Width - 12.00 mts) <u>2700.93</u> <u>3.2411</u></p> <p>As there is no alternative to that for Formation of BT road, proposal is being furnished for diversion of forest land.</p>


