- 4. DGPS map for Compensatory afforestation land of 20.37 Ha against a previous proposal of 8.6199 Ha under DFO/Hazaribagh(East) has already been submitted earlier. Against this earlier proposal only 17.2398 Ha was required for Compensatory afforestation that is double the area of 8.6199 Ha. Now double the area of 1.7587 Ha in this instant proposal comes to 3.5174 Ha as CA land required. From the earlier submitted DGPS map of 20.37 Ha land. 20.37-17.2398 = 3.1302 Ha is available area for this proposal. For remaining 3.5174-3.1302 = 0.3872 Ha land may be indicated by SFD, for which DGPS map would be provided. DGPS map of earlier proposal for 20.37 Ha is being attached herewith as Annexure- C.
