This has reference to the above letter B/20/Land/358/2016-17, dated 03/11/2016 seeking certain clarification in Geo digital map submitted for the above amendment proposal

We had reviewed the drawings and found some minor changes and these are corroborated during the site visit conducted on 27.10.16 along with forest officials at Panvel/Kalhe. The coordinates corresponding to this alignment to be read as below.

Starting Co-ordinates	18 50 35.59 N	73 02 47.80 E
Ending Co-ordinates	18 50 32.82 N	73 03 20. 34 E

The corrected drawings incorporating the above were submitted at your office on 03.11.2016 during the visit to your good office at Alibag.

We would like to submit once again that the additional diversion is limited only to 0.8878 hectares and total amendment to stage 2 approval remains at 10.2918 hectares.

This being a national importance project with a stiff completion schedule of March 2017, request for approval of this proposal involving minor amendment of 0.8878 hectares of forest.
