उक्त सन्दर्भित पत्र के क्रम में आपके द्वारा दिनांक 28.11.2018 के पत्र में जो कमियां पायी गयी थी, उनका बिन्दुवार निराकरण निम्नवत् है:-

5	The FRA certificate uploaded in online part I is without mentioning date and a lot of unnecessary document and more than one copy of same document is attached with the FRA certificate. The state Govt. may upload only required annexure with mentioning date of the committee proceeding in each annexure with the FRA certificate.	The related objections have been removed related to FRA, unnecessary document and etc.
6	The digital map of area proposed for CA is provided on google earth map which does not serve any useful purpose may provide/ upload GIS software generated geo referenced digital map of the area proposed for CA providing geo coordinates at all corner points in shape (polygon/closed area) file. 7	The density 0.5 for the area proposed for diversion appears to be incorrect in view of the number of trees proposed to be felled. The state Govt. may review the density and provide correct density in online Part II.	The objections related to this point will be removed by D.F.O. office.
8	The NPV calculation is not provided with the proposal.	The objections related to this point will be removed by D.F.O. office.
9	The CA stipulation against total forest area diverted in the district is not commensurate. The State govt may do the necessary correction and if require, clarify the discrepancies.
