

DETAILED REPORT ON VIOLATION OF PROVISIONS OF FOREST ACTS

The diversion case started when a application received from Sh Rohit Garg (Owner) S/o Sh. Gian Chand, Partap Colony, Mehas Gate, Patiala, Distt Patiala for diversion of 0.0551 ha. of forest land permission for construction of approach Access M/s R.K. Enterprises (Proposed Hotel by Rohit Garg S/o Sh. Gian Chand) Vill: Rohti Khas on Nabha-Patiala Road KM 2-3 R/s, Tehsil Nabha & Distt.Patiala under Forest Division:Patiala. The above application endorsed to Forest Range Officer, Nabha for site inspection along with map of the site. Forest Range Officer, Nabha has reported to this office that 0.0551 hac. forest area, 20 trees and 18 Plants will be affected by this diversion and the user agency has violated the act by using 38 Sqmtr on Patiala-Nabha Road road KM 20-21 L/S prior approval of G.O.I. Forest Range Officer, Nabha has issued a damage report No. 956841 dated 22-05-2017 against the user agency under Indian Forest Act 1927 and the user agency has deposited the penalty. The user agency has violated, for which the DR. 956841 dated 22.05.2017 has been issued. Since the user agency has obtained NOC from the DTCP Department on 18.11.2019 after the violation date, the case is "recommended for approval with Ten times penal CA" as per para no. 4 of proceeding received by PCCF letter No. 16133-35 dt. 5-8-2009.
