3.	Since violation is reported in this case, State Govt. should initiate action against the user agency under the provisions of Indian Forest Act, 1927 and other State Acts and submit the valid reasons and exceptional circumstances apt to justify condonation.	We hereby undertake that, Curve improvement work has been done as per khasra map therefore we have not violated the provisions of FCA, 1980. In order to regularize the matter as it was done unknowingly, therefore If forest department has considered this as violation in this case, we are ready to comply the condition's that will be imposed by the MoEF&CC / State Forest Department.
