	(iv) Justification for locating the project in forest area	The area to be covered under this scheme hfalls under Gran Panchayat Tandi, Saroa, Tharjoon, Mushrani, Bassi, Devdhar, Kharsi & Kotla Khanula in Gohar Block Tehsil Chachiot District Mandi (H. P.). There are 190 Nos partially covered (PC) Habitation of 29 Nos Census villages under these Panchayats. The ultimate population covered is 16970 persons. The design water requirement worked of this scheme out to be 1380840 liters per day. The scheme is proposed to augment various exciting schemes which experiences swear spell of drought during summer and discharge of their sources reduces to less than 0.5 LPS. Therefore, during drought season, the crises worsen and department every year deploy tankers in the area which further restricted due to non-availability of roads to all habitations. Therefore, it is a very important to augment these. As such this scheme has been proposed to provide ample quantity of water to the public of the area. The scheme has been approved under Jal Jeevan Mission of GOI.
