

SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF (For the forest land to be diverted under FCA)

5-1: A Proposal has been received by this office from अधिकारी अभियन्ता, अस्थाई खण्ड, लो०नि०वि० श्रीनगर मु०-कीर्तिनगर, जिला-ठिहरी गढवाल for diversion under (FCA-1980) of 1.052 ha. of forest land non-forestry purpose. The project envisages the use of forest land for construction of जनपद ठिहरी गढवाल के विधानसभा क्षेत्र देवप्रयाग के अन्तर्गत चौण्डी, भदली, घटधार, थानकोट, घेरा होते हुए ग्राम-सिमलासू बैण्ड तक मोटर मार्ग का निर्माण कार्य। The site inspection of the land involved in the proposal has done by me on date- 30/10/2018.
