Complete Geo reference map showing RF at one location and PF at two locations along with title and legends has been uploaded.
4	In additional information details, in upload detail area calculation of forest land, the width of proposed road has not been mentioned again.	Area has been calculated by AutoCAD tool, Width has been calculated and this is an average width. Width of the proposed road in RF section is 45m, in PF



	land, the width of proposed road has not been mentioned again.	location it varies between 65m to 90m as per the ERoW.
5	In additional information details, Uploaded Forest gazette have not been duly verified by present DFO and highlighting the proposed alignment.	Proposal to DFO can only be submitted after locking of proposal at Nodal level. DFO at present is not entertaining verification of Gazette notification without proposal. In addition to above, It is also informed that Gazette Notifications published by Publication department, GOI needs no verification. Further, Above Gazette pertains to Forest department itself which can be verified at your end. NHAI proposal can not be returned for reasons attributable to forest department and the same will be verified by DFO after submission of proposal in physical form to DFO, which is an activity to be carried out after locking of proposal.
