**13) Specific recommendation of DCF for acceptance or otherwise of proposal with reasons, for site specific**

The proposal is recommended for acceptance as the proposed forest lands is use for laying of OFC duct & cable within Row & road passing through forest land at Jalgewadi, & Chorjwadi, Dist. Satara. The road selected as the maximum area will be covered for mobile network and easy maintain for long period.

Additional C.E O, Zillah Parishad Satara has sanction for laying of underground OFC duct & cable within the ROW of existing road. Vr. 8 & Vr 123. Project Authority has obtained the permission from Govt.of Maharashtra, Department of Information Technology Bombay.

Proposal is recommended for C.A. may not be levied to this proposal, as proposal for laying of underground OFC, within RoW of existing road, Area not felling in N.P. & WL. Sanctuary, & there is no need of felling of trees. (Fulfil the conditions laid by MoEF guideline FC- 11/165/2019 Dt 27/07/2020) Authority has not started work in forest land and in non-Forest land. P. A. will start work after sanction by State Govt.

There is no alternative non-forest land available, Proposed work is as per site specific. The area is to be diverted is not sensitive and will not have any adverse effect on the ecology of area. Hence this proposal is recommended for diversion of the forest land for laying of underground OFC Cable.
