
Sub: - NOC for overhead crossing of 132 KV Jagadhri-Tapri transmission line of DFCCIL over Augmentation Canal at RD 6.292 Km.

Ref:- Your office No. NRI/RKE/DFCC/TL dated 23.12.2022 and CPM/MTC/EL/CC dated 13.02.2023

As explained and requested by you vide your letters under reference, the necessary NOC/Permission is hereby granted for the subject cited work as per direction of S.E. YWS Circle, Karnal as per Note No.3 of E-office on dated 27.03.2023 with the following conditions:-

1. Your office shall deposit all applicable charges i.e. processing fees, caution deposit of 5 Lac in shape of demand draft in favour of Executive Engineer, Indri W/S Division, Karnal before execution of the work. 50% of the caution deposit shall be refunded after satisfactory completion of the work and remaining 50% shall be non refundable and to be kept by the Department as security till the work remains in position.
2. The ownership of land will remain with Haryana Irrigation Department.
3. In case of any eventually for any mishap/damage to any life/property/machinery during the course of execution work, the responsibility will rest upon with G.M. Power Grid Corporation of India Ltd.
4. After approval of the proposal by the competent authority an agreement shall be executed by the DCO/XEN, Karnal on behalf of the Governor of Haryana with applicant stipulating all the terms & conditions for safeguard of the state interest as per the terms of Draft policy.
5. G.M. Power Grid Corporation of India Ltd. will be bound to shift the electric lines in the interest of department, if required at later stage for further development of canal network and will not claim any compensation on this account.
6. The NOC would be one time and for this particular work only.
7. The operation & maintenance of the said electric line will be done by the G.M. Power Grid Corporation of India Ltd.
8. G.M. Power Grid Corporation of India Ltd. shall deposit all the applicable charges i.e. processing fees & caution deposit before execution of work to cover O&M of the Canal.
9. The safety of the canal should be ensured.
10. G.M. Power Grid Corporation of India Ltd. Authority will remove all the temporary structure constructed during the execution of work at his own cost.
11. The safety and smooth movement of the traffic shall be ensured by the G.M. Power Grid Corporation of India Ltd. during the execution of work and there shall be no inconvenience to the traffic.
12. The work will be executed under the supervision of SDO in-charge of the canal.

13. The detailed design and drawing of the proposed electric line will be countersigned/ vetted by the Irrigation Authority before execution of work.
14. The work of the proposed electric line will be executed during non monsoon period.
15. G.M. Power Grid Corporation of India Ltd. will ensure smooth running of water in the canal during execution of work.
