With reference to the above cited memos under caption subject the point wise compliance report of the discrepancies / deficiencies observed is furnished hereunder for favour of kind information and necessary action.

1. Desired correction has been made in the revised forwarding letter under A-1 brief description of the project.
2. In the existing land use plan jointly verified by the Forest, Revenue & Mining Officials during March-2000 (plate-IV) in which, year of broken (pre-80 or post-80) has not been mentioned. However the User Agency has submitted a detail notes enclosed as Annexure-1 vide his letter No.14973 dated 28.09.2018, which may be perused.
3. The KML files in CD form of both the lease area and the area identified for CA is submitted herewith.
4. In revised forwarding letter under C2-Net Present Value (NPV) correction / addition has been made accordingly.
5. The Daitary- Bansapani Railway line Project has obtained Stage-II approval over an area of 370.2567 vide letter No. 8-56/93-FC dt. 28/29.04.1994 of MoEF, GoI. Further, DGPS survey map has been certified by the ORSAC & mentioned that 4.535 ha forest land of village- Khuntpani in Bansapani ML area is coming within Railway corridor of Daitary- Bansapani Railway line.
6. In the revised forwarding letter under C3 necessary correction has been made accordingly.

**Sub: Proposal for diversion of 183.218 ha Forest land involved in the mining lease area over 380.40 ha of Banspani Iron Ore Mines of M/s OMC Ltd in Keonjhar district, Odisha.**

Ref: Proposal No. FP/OR/MIN/28732/2017, State Sl. No. OR-045/2017 dated. 11.09.2017.

Proposal for diversion of 183.218 ha of forest land involved in the mining lease area over 380.40 ha of Banspani Iron Ore Mines of M/s OMC Ltd in Keonjhar district, Odisha, has been received online from the Addl. Principal Chief Conservator of Forests, Forest Diversion and Nodal Officer, FC Act. O/o the Principal Chief Conservator of Forests, Odisha, Bhubaneswar vide No. FP/OR/MIN/28732/2017, State Sl. No. OR-045/2017 on dated 11.09.2017. The submitted proposal, over 183.218 ha forest land including 13.05 ha forest land located within safety zone all along the inner side of the ML boundary of the mining lease, in 5 sets is sent herewith for approval under section-2(ii) of Forest (Conservation) Act, 1980 (Amended) after due scrutinization in compliance with the guideline F No. 8-78/1996-FC(pt.) dt.10.03.2015 read with F No. 8-78/1996-FC(pt.) dt.09.03.2016 of MoEF&CC, Govt. of India.

**A. Brief description of the Project Proposal**

**A1 - Brief description of the Project**

The mining lease of Banspani Iron ore mine was granted over 443 ha vide letter No. III (A) M-25/65- 3521-MG dated 23.04.1965 of Govt. of Odisha Mining & Geology Department(copy enclosed as Annexure- II). Subsequently, M/s OMC Ltd has been allowed to execute the mining lease over an area 380.40 ha arrived at after survey and demarcation vide letter No. III(A)M-18/66 dated 09.02.1966 of Mining & Geology Department, Govt. of Odisha. The said Mining lease was executed on dated 21.05.1966 for a period of 30 years with effect from 21.05.1966 to 20.05.1996 over an area of 380.40 ha. The first RML was applied on 10.05.1995 (receipt by the Collector, Keonjhar on dated 17.05.1995) one year prior to expiry of the original mining lease period over 380.40 ha which comprises 129.435 ha Reserved Forest, 13.382 ha Village Forest, 45.900 ha DLC Forest & 191.683 ha non-forest land. Further, Govt. of Odisha, Steel & Mines Department vide letter No. 4900/F&E dated 25.06.2018, extended the validity period of lease for a further period of 20 years from 21.05.2016 to 20.05.2036 subject to the execution of supplementary lease deed for such lease extension period.

The mining lease granted over 380.40 ha involves 129.435 ha Reserved Forest, 13.382 ha Revenue Forest, 45.900 ha DLC Forest & 191.683 ha non-forest land. Nonetheless, it is also mentioned that the said mining lease has been surveyed through DGPS survey and the DGPS surveyed area of the mining lease involves 128.45 ha RF, 12.192 ha Revenue Forest, 44.283 ha DLC Forest, 2.828 ha Non-forest land recorded as Forest as on 25.10.1980 and 192.647 ha Non-forest land. The said DGPS surveyed area of the mining

lease has been certified by the Tahasildar, Barbil and the certificate on Non-forest land recorded as Forest as on 25.10.1980 furnished by the Tahasildar, Barbil is enclosed herewith as **Annexure- I**.

The Mining Lease of Banspani Iron Ore Mines of M/s OMC Ltd lies between longitude E 85°-25'-00" to 85°-26'-38" and latitude N 21°-57'-45" to 21°-09'-55" in Survey of India topo sheet No. F 45 H8 & F 45 N5. As per Sabik records certified by the Tahasildar, Barbil the total forest land involves in the ML is 187.753 ha which involves RF- 128.45 ha, Revenue Forest- 12.192 ha, DLC Forest- 44.283 ha & Non-forest land recorded as Forest as on 25.10.1980- 2.828 ha. The instant diversion proposal has been submitted over 183.218 ha (126.22 ha RF, 10.021 ha Village Forest, 44.149 ha DLC Forest and 2.828 ha Non-forest land recorded as Forest as on 25.10.1980) including safety zone area over 13.05 ha Forest land for diversion under Section-2 (ii) of Forest (Conservation) Act, 1980. South-Eastern Railway for Jakhapura- Bansapani Railway corridor has acquired 4.535 ha forest land (RF- 2.23 ha and Revenue Forest land- 2.171 ha and DLC Forest land- 0.134 ha) within the mining lease area.

The Mining Lease contains total mineable reserve of 14.735 million tonnes of Iron Ore. The annual production capacity is 1.00 million tonnes iron ore. This project will generate direct and indirect employment for more than 100 and 500 local tribal people respectively.

## **A.2. Physiography and Geological formation**

Banspani Iron Ore mines of M/s OMC Ltd, located within longitude E 85°-25'-00" to 85°-26'-38" and latitude N 21°-57'-45" to 21°-09'-55" in Survey of India topo sheet no. F 45 H8 & F 45 N5, consists of Reserve Forest, Revenue Forest, DLC Forest land and Non-Forest land recorded as Forest as on 25.10.1980. This site falls under the physiographic-Joda Barbil plateau extending from Chamakpur to the boarder of Singhbhum of Jharkhand in north and boarder of Bonai in the west. This region is an extension southwards of Singhbhum rocks. This group of rocks comprising Trap, Tuffites, Shale, Quartzite, Phyllite, Banded Haematite Jasper and Banded Haematite Quartzite form high hill ranges with narrow deep valley. This region is characterised by massive deposit of iron and manganese are associated with B.H.J. and shales. The iron ores precipitates are in the form of oxide, carbonates, silicates and sulphides. The most characteristics feature of the iron ore i.e haematite is it's availability in the form of massive beds, pockets and large lensoid soil bodies. Hard massive, Laminated, Lateritoid & Blue dust are the major form of ore located in this physiographic zone. The mineable reserve of Iron ore established so far is 14.735 Million Ton of + 45 % Fe grade.

## **A.3. Floristic- Faunal Composition**

The geological formation of this area is quite suitable for growth of Sal. Sal constitutes around 70 to 75% of the top canopy. The middle storey is un-conspicuous. The quality of Sal varies from all India Quality II to IV. Quality II sal is mainly confined to the valleys while Q III occurs on the hill slopes of moderate gradient. Q IV sal mainly confined in the ridges. Q I sal is completely absent.

The principal associates of Sal includes *Terminalia alata*, *Lagerstroemia perviflora*, *Anogeissus latifolia*, *Terminalia belerica*, *Syzygium cumini*, *Mangifera indica*, *Schleichera leosa*, *Adina cordifolia*, *Pterocarpus marsupium*, *Bombax ceiba*, *Bridelia retusa*, *Madhuca indica*. The middle story is represented by *Syzygium cumini*, *Ougeinia ougenensis*, *Careya arborea*, *Treema orientalis*, *Embllica officinalis*, *Cassia fistula* etc. The shrubs and undergrowth are characterized by *Indigofera pulchella*, *Ardisia solenacea*,

*Flemingia chhapar*, *Helicteres ixora* and *Clerodendron viscosum* etc. The prevailing climbers include *Bauhinia vahlii*, *Combretum decandrum* and *Beutia parviflora*. The grasses over the forest floor include *Chrysopogona ciculatus*, *Imperata cylindrica*, *Dicanthium carricosum*, *Cynodon dactylon* etc.

The canopy density of the prevailing forest growth in the applied forest land varies from 0.2 to 0.8. The prevalence of pole crop to middle aged Sal crop in this area indicates the shifting cultivation in the past and the crop can therefore be considered to be secondary origin. But the secondary moist deciduous forest replacing primary forest of the same type is not differentiated as almost all the primary forests have been practically influenced by human interference. The prevailing forest growth & structure of the forest crop in the proposed forest land is categorised as 3C/C2e(iii) Moist Peninsular Valley Sal. The canopy density on average is **0.5**.

Movement of wild elephants is often witnessed in Baitarani Reserved Forest and adjoining Forest land. The applied site falls under elephant habitat zone- 2 as mentioned by ORSAC, Bhubaneswar.

### **B2. Forest Land**

The mining lease over 380.40 ha involves 187.753 ha forest land (128.45 ha Reserved Forest, 12.1920 ha Village Forest, 44.2830ha DLC Forest, and 2.8280 ha Non-forest land recorded as Forest as on 25<sup>th</sup> October 1980) as certified by the Tahasildar, Barbil. Out of which 4.535 ha forest land (RF- 2.23 ha and Village Forest land- 2.171 ha and DLC Forest land- 0.134 ha) has been acquired by South-Eastern Railway for Jakhapura- Bansapani

Railway corridor and obtained Stage-II forest clearance dated 28/29 April, 1994. The purpose wise break-up of 183.218 ha of forest land submitted for diversion, is produced hereunder-

The total forest land of 183.218 ha (including 45.992 ha already broken up forest land) of the lease hold area has been proposed for diversion to be utilised for various mining purposes in the mining lease. The forest land includes 126.22 ha of RF, 12.849 ha of Revenue Forest (which includes 2.5050 ha forest area which was forest prior to 25.10.1980 and later converted to non-forest without prior approval of Central Govt.), 44.149 ha Forest as per DLC. The purpose-wise break-up of the total land required is indicated below-

### **B.3 Tree Enumeration.**

As per sample enumeration and extrapolation there are 14760 nos. of sound, 36294 Nos. of unsound trees in the virgin forest land over 137.226 ha and 349 nos. of sound, 1291 Nos. of unsound trees in the broken up forest land over 45.992 ha enumerated over 183.218 ha forest land involved in the Mining Lease in the instant proposal. The species wise

and diameter class wise abstract of enumerated trees in respect of virgin and broken up land in separate sheets is enclosed as **Annexure –XXVII**.

#### **B.4 Cost benefit analysis.**

The Cost Benefit analysis has been worked out as per the guide lines of Forest (Conservation) Act, 1980 and enclosed in the proposal as **Annexure- IXA**. The Cost Benefit ratio is 1:48.89.

#### **B.5 Re-settlement and Rehabilitation.**

The project does not involve displacement of any human habitation. Therefore, Re-settlement and Rehabilitation plan is not insisted upon.

#### **B.6. Safety Zone**

As certified by the Tahasildar, Barbil the mining lease over 380.40 ha involves 128.45 ha RF, 12.192 ha Village Forest, 44.283 ha DLC Forest, 2.828 ha Non-forest land recorded as Forest as on 25.10.1980 and 192.647 ha Non-forest land. The total Non-Forest land involved in the mining lease is 192.647 ha. The total forest land including non-forest land recorded as Forest as on 25.10.1980 located in the safety zone 7.5 mtr strip all along the inner side of the mining lease is 13.05 ha. The details of Forest and Non-Forest land located in the safety zone of the mining lease, in respect of the submitted diversion proposal, is furnished hereunder-

The Addl. General Manager (Geo), Power of Attorney Holder, M/s OMC Ltd undertakes to bear the cost of NPV if enhanced upwards in future.

#### **C3. Wild Life Management- Site Specific Wildlife Conservation Plan and Regional Wildlife Management Plan.**

Site Specific Wildlife Conservation Plan has been approved by the PCCF, (Wildlife) & CWLW, Odisha vide memo No. 3040/1WL-C-FC-SSP-239/10 dt 24.04.2010 with a financial outlay of Rs. 146.00 Lakh (Rs. 39.00Lakh for the project area to be implemented by User Agency and Rs. 107.00 Lakhs for the project impact area to be implemented by DFO, Keonjhar). The demanded amount 107.00 lakh has not yet been deposited by the User Agency. Further, the User Agency has undertaken to deposit the Site

Specific Wildlife Conservation Plan and Regional Wildlife Management Plan. The undertaking to this effect furnished by the User Agency is enclosed as **Annexure- XIV**.

#### **D. Statutory Clearances**

##### **D.1. Forest Clearance**

No forest land has been diverted under section- 2(ii) of FC Act, 1980.

###### **Violation**

As per the observation of the Hon'ble Justice M. B. Shah Commission, production figure mentioned, in the Annexure- IV- A of the 1<sup>st</sup> report on illegal mining of Iron and Manganese Mines in the State of Odisha, illegal production of 148242 tonnes Iron ore from 2002-03 to 2004-05 without obtaining approval under FC Act, 1980.

###### **Action taken**

For the illegal production of mineral, OR case No. 164CH of 2014-15 has been booked. Prosecution sanctioned and submitted in the Court of JMFC, Barbil vide PR No. 31 of 2014-15 dated 12.02.2015. The case is sub-judice.
