**PROVISION OF INTERNAL ROADS CONNECTING MAMUN MILITARY STATION TO
AJEYA GARRISON (PHASE-I) (JOB NO : MWP/19-20/IV/49/MAMUN) (AMWP 2019-
20) (LIST IV SERIAL NUMBER 49)**

1. Under the provisions of Government of India, Ministry of Defence letter No B/01247/Q/Policy/Works Procedure/237/D(Wks-I) dt 21 Jun 2007 read in conjunction with Schedule 14 (Civil Works) to Ministry of Defence (Finance) Order No Coord A-102 dated 20 Apr 2005, I am directed to convey the sanction of the General Officer Commanding-in-Chief Western Command to accept the necessity and accord administrative approval for "Provision of internal roads connecting Mamun military station to Ajeya Garrison (Phase-I)" at an estimated cost of Rs 1175.51 lakhs (Rupees one thousand one hundred seventy five lakhs and fifty one thousand only) as per Approximate Estimates Part I and II attached.

2. The work caters for long requirements in terms of Para 13 (b) of DWP 2007 and will be carried out by MES or under arrangement made by them.

3. The expenditure involved will be debitable to Major Head 4076 Capital Outlay on Defence Services, Sub Major Head 01, Minor Head - 202, Debitable Head (a), (2) Construction of New Works.

4. The work is hereby released for execution during FY 2019-20 with an initial allotment of Rs 15,000/- (Rupees fifteen thousand only). Time required for completion of the work is 208 week from the date of release of work.

5. This letter is issued with concurrence of IFA (WC) conveyed vide their Minute Sheet No IFA/WC/Works/IR-Mamun/AGN-353 dt 26 Mar 20, under condition that NoC from Forest Auth must be obtained as per GoI MoD letter NO 1(6)/2016-D/Works-I dt 25 Jul 2017 before finalisation of the tender & committing liabilities to avoid administrative/legal issues later.
