Sir,


I am directed to refer to CCL's letters No. REV/17/1488 dated 23.2.2017 and CCL/REV/2017/2149-54 dated 01.08.2017 and directions of CERC in their Order dated 20.3.2019 (copy enclosed) on the above mentioned subject and to convey the approval of NOC with the following conditions:

- i). Right of Way (ROW) shall not be transferable or heritable right. It shall not constitute any right or title in favour of NKTL except to the extent specified in the Memorandum of Understanding (MoU);
- ii). If CCL requires this land for production of coal, in such situation, it is essential that implementing agency will take responsibility to arrange for shifting/diverting the transmission lines with 24 months subsequent upon issuance of the notice period by CCL, failing which NKTL will be liable to pay the price of the coal to CCL, equivalent to the loss of production suffered by CCL due to non-diversion of transmission lines;
- iii). If shifting/diverting of transmission line will be required in future, route for the same purpose, will be such which does not under coal mining or block any coal bearing area;
- iv). It shall not constitute or create any right of easement; and
- v). In case of any dispute arising from any aspect of the ROW, the decision of the CCL shall be final and binding on NKTL.


This issues with the approval of Hon'ble Minister of Coal and Railways.
