The Gadchiroli unit of Maharashtra police has submitted the proposal to Govt. of Maharashtra for sanction of out post at village Nawezari. Naxal activities in this area are increased, as this area lies near Chhattisgarh border so, to Prevent and stop the naxal activities and maintain law and order new Arm out Post Nawezari is essential to be started as early as possible. The police Department have explored all other possible alternatives to find a suitable land required for construction of administrative building and residential quarters for police officers and men working at proposed Arms out Post Nawezari. Nawezari is well connected to Korchi Police Station by Road, owing to the law and order situation by naxal activities the selected site is the best possible option for implement anti-naxal operation.

There are few big trees at the selected area but we propose to cut down only which will be hurdle for construction rest of all the tress will be conserved.

Thus, as per forest conservation Act 1980 Article 2.4 page No. 6 the proposal for acquisition of forest land requires for Arms out Post Wangeturi is submitted in Prescribe preform.

### Justification of Alternative site for Arms Out Post at Nawezari

Demined forest land of 2.00 Hector from Survey No. 58, out of 32.57 Hector from mouza – Nawezari Taluka- Korchi Dist. Gadchiroli For construction of new Administrative Building and Residential Quarters for Police officers and men. These are suitable site in view security of post transportation, good communication, controlling naxal activities to provide security to major project of national interest and also for establishing interstate check post in future.

Area of Nawezari bears a wide forest cover so; it is highly sensitive in view of naxal activities. To implement effective anti- naxal operation in order to Prevent naxal activities and a maintain law and order situation Arms out post at Nawezari should be start functioning at earliest. Construction of Administrative building is necessary for keeping arms and ammunition, while residential quarters are essential for accommodation of police officers and men. Proposed site in survey no. 58 is along Korchi – Nawezari rods so, if any law and order situation arises, rescue forces from Gadchiroli headquarter can reach the post within short period of time.

There is no other suitable site and revenue and available at mouza – Nawezari Taluka- Korchi Dist. Gadchiroli. Thus we request you to sanction forest and of 2.00 hector from survey no.58 for construction of administrative building and residential quarters for Aop Nawezari.




