This is to inform you that IRCON International Limited is executing Udampur-Srinagar-Baramulla New BG rail line project on behalf of Northern Railway.

M/s Gammon Engineers and Contractors Pvt. Ltd.(GECPL) was allotted the work of executing the construction of balance work of Tunnel T-48. The work was allotted by IRCON vide LOA No. under ref (1) above. At present the work is under. M/s GECPL vide their letter under ref (5) has applied an indent for an additional area of 0.63 Hectare near Jawari, Sumber for allotment of forest land bearing Khasra No. 1646, for stone quarry purpose to produce stone aggregate. They have already your good self vide their letter under ref (2) & (3) in this regard.

In this connection, it is to inform you that the earlier source approved is inadequate to complete the balance works of Tunnel T48 and thus the agency is in great need of additional source at present.
