<u>IMPROVEMENT OF ROAD FROM KM 121/0 TO KM 154/0 OF NAKAREKAL TO MALLAMPALLY OF NH – 365 IN JAYASHANKER DISTRICT IF TELANGANA STATE C.A. (DOUBLE DEGRADED FOREST) IN MULUG RANGE, FOREST DIVISION, MULUG.</u>

1) Introduction of the Scheme:-

The Executive Engineer, (R&B) National Highways Division, Warangal has submitted proposals for diversion of 25.00 Ha of forest land for improvement of road from Km 121/0 to Km 154/0 of Nakarekal to Mallampally of NH – 365 in Mulug Range in Forest Division, Mulug.

2) Suitability of the Area:-

The Executive Engineer, (R&B) National Highways Division, Warangal has requested the Forest Divisional Officer, Mulug that C.A. can be raised in double the degraded forests land in Forest Division, Mulug. Hence the CA area of 50.00 Ha is identified in double degraded forest area in Compt. No. 596, 597 in Jakaram – I R.F., Pandikunta Beat of Mulug Range.

3) Areas identified for Compensatory Afforestation and species.

Accordingly 50.00 Ha., is identified in contiguous in Reserve Forest compartment No. 596, 597 of Jakaram – I R.F. Pandikunta Beat in Mulug Range.

Keeping the suitability and management point in view, it is proposed to raise Miscellaneous species through ANR Method in 10.00 Ha and tending operations in 50.00 Ha each at an espacement of $5M \times 5M$.

The details of areas to be planted, species and different techniques as follows

4) Planting Technique:-

The plantation under this scheme is proposed to be raised by adopting ANR method. Advance works like clearance of miscellaneous growth will be taken up and Miscellaneous species plantations will be taken up under ANR method.

It is proposed to raise plantations of Miscellaneous under ANR method with 5M x 5M.

Basal dressing with super phosphate will be done to boost up the root system. Weeding and soil workings are provided. The plantation will be provided with a watcher up to 8th year maintenance of plantations for protection.

The entire area of C.A will be planted within One year i.e., during 2017 – 18.

5) Scheme Implementation Agency:-

The Forest Divisional Officer, Mulug will be the project implementation and monitoring agency and works will be taken up through concerned Forest Range Officer.

Raising of successful C.A. Plantation requires frequent inspections and close monitoring by the Forest Range Officer and senior officers.

6) Monitoring Mechanism :-

The Forest Divisional Officer, Mulug and District Forest Officer, Jayashanker / Conservator of Forests, Warangal will be closely monitoring the implementation of C.A. scheme by regular inspection and ensuing maintenance of connected records like nursery journals, plantation journals, Cash books, work register, Measurement books, etc., Monthly Progress of planting and maintenance along with expenditure will be submitted to the Prl. Chief Conservator of Forests, Telangana Hyderabad. Other Senior officers of Forest Department of Telangana and Chief Conservator of Forests (Central), Bangalore will also be monitoring the implementation of C.A. scheme.

7) Period of the scheme :-

Period of the scheme is for (10) years which includes 1st year of Advance works and nursery raising, 2nd year and 3rd year of raising of plantations and (8) years of maintenance commencing from 2016 - 17 to 2025 - 26.

8) Cost Structure:-

The cost of the scheme is worked out adopting present F.S.R. of 2016 - 17 and wage structure of Rs. 323/- per day (as approved by the District Collector, Warangal). The total year wise cost structure of the project to an extent of 50.00 Ha., is shown in Annexure – I. The details of requirement of funds and year wise action plan are shown in Annexure-II. Unit costs of different planting techniques are shown in Annexure – III to V. The Abstract of the scheme is as follows:
