TO WHOM SOEVER IT MAY CONCERN

In compliance of the Ministry of Environment and forest (MoEF), Government of India's letter No. 11-9/98-FC (pt.) dated 3rd August 2009, where in the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ("FRA", for short) on the forest land proposed to be diverted for non- forest purposes, it is Certified that 0.155 hectares of forest land proposed to be diverted in favor of Construction Division Jumpin Adventure Pvt. Lmtd. Company MohanChatti Distt- Pauri Garhwal, Uttarakhand for Construction of Bunjy Jump, Gaint Swing, flying fox in Mohan Chatti falls with in jurisdiction of Bijni Chhoti/Jogiyana Village in Yamkeshwar tehsils.

- (a) The Complete process for identification and settlement for rights under the FRA has been carried out for the entire 0.155 hectares of forest land proposed for diversion. A copy of records of all consultation and meetings of the Forest Level Committee(s), Gram Sabha (s), Sub-Division Level Committee(s) and the District Level Committee are enclosed as annexure 01 to annexure 02.
- (b) The proposal for such diversion (with full details of the project and its implications in vernacular/local language) have been placed before each Concerned Gram Sabha of forest-dwellers who are eligible under the FRA.
- (c) The each of Concerned Gram Sabha(s), has Certified that all formalities/ processes under the FRA have been carried out, and that they have given their concent to the proposed diversion and the compensation and ameliorative measures, if any having understood the propose and details of proposed diversion. A copy of Certificate issued by the Gram Sabha of Bijni Chhoti/ Jogiyana Village is enclosed as annexure 01 to annexure 02.
- (d) The discussion and dicisions of such proposals had taken pace only when their was a quorum of minimum 50 % of the members of Gram Sabha Present.
- (e) The Diversion of forest land for Facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Gram Sabha have given their Conset to it.
- (f) The rights of primitive drival groups and Pre- Agricultural Communities, where applicable have been specifically safeguarded as per section 3(1) (e) of the FRA,.
