No. 24/Lease-U/446/03/HWB/09/15/14358 – In continuation of this office Notification *vide* No. 24/Lease-U/(446)/03/HWB/09/15/1587, dated 3rd September, 2015 duly notified in the Haryana Government Gazette No. 36/2015, dated September 8, 2015, the Haryana Waqf Board, in exercise of the powers conferred under clause [(na) of Sub-section (2) of Section 32 of the Waqf Act, 1995 (Act No. 43 of 1995) as amended by the Wakf (Amendment) Act, 2013, has revised the lease rent/chakota money for agriculture waqf lands situated within the jurisdiction of Haryana State as enumerated at Sr. Nos. (ii) to (vii) in the Note of the previous Schedule Rates for agriculture waqf lands fixed in the year 2011 *vide* Haryana Government Gazette No. 4, dated January 25, 2011 keeping in view the price rise and prevailing market rate of rent with immediate effect.

There will be minimum increase in reserve lease rent/chakota money of agriculture waqf lands @ 60% in situations as enumerated at Sr. Nos. (ii) to (vii) in the Note of the previous Schedule Rates of the Board for agriculture waqf lands duly notified in the year 2011 as mentioned in Para (1) above. Rest of the reserve price/chakota money for agriculture waqf land will remain same already notified *vide* Notification No. 24/Lease-U/(446)/03/HWB/09/15/1587, dated 3rd September, 2015 and duly published in the Haryana Government Gazette No. 36/2015, dated September 8, 2015.
