This is with reference to the online EDS raised by AIGF(HQ) dt 7-11-2025 on the subject cited above. In this context this is to inform you that the EDS raised by AIGF(HQ) has been attended as below: -

1	It is been reported that the user agency has submitted a proposal FP/HP/IND/35171/2018 for diversion of 0.0934 ha of Protected Forest (0.062 ha) and Gair Mumkin Machine (0.0314ha) for renewal of already established Stone Crusher. The instant proposal pertains to diversion for mining lease, safety zone, approach road and for stacking of raw material. Therefore, the State Government is requested to clarify if these two proposals are interlinked and, if so, reason for applying separately may be submitted.	The instant proposal no FP/HP/MIN/34194/2018 and another proposal no FP/HP/IND/35171/2018 have been submitted by the same user agency i.e. Smt. Kanegtu Devi Prop M/s Bushahr Laghu Udyog. Further the proposal no FP/HP/MIN/34194/2018) is for additional land required for quarry to feed the existing Stone Crusher which was in operational since 1980, Hence as per rule Form -A Applies. Further, the proposal no FP/HP/IND/35171/2018 pertain to renewal of diversion of existing stone crusher which was operational since 1980 for which FCA was accorded vide previous proposal no FP/HP/MIN/161/1997, hence as per rules the FORM-B apply.
