In view of the urgency expressed by the commercial Manager, Bhadrachalam Paper Boards Limited, in his reference 1st cited and in pursuance of the instructions of the conservator of Forests, Khammam issued in the reference 2nd cited permission to conduct survey for laying out the pipe line River Godavari to Factory Site which passed through Kistasagar Forest Block and to clear the under growths and bushes to a width of 8' to 10' wide is hereby accorded subject to the following conditions.

- 1. The centre line of the alignment of the pipe line inside the Forest boundary should be peg marked on the ground by the authorities of Bhaddachalam Paper Boards.
- 2. All standing growth through out the length and width of the pipe line which required to be felled shall be emmerated and a list prepared in a marking book by the Range Officer in presence of the representative of the Bhadrachalam Paper Boards Limited. A copy of the enumeration list should be furnished to this office as well as to the commercial Manager, by the enumerated staff Bhadrachalam Paper Boards Limited. Secunderabad duly signed by the enumerated staff and the representative of the Bhadrachalam Paper Boards Limited.
- 3. After the tree growth is enumerated the standing growth shall be cut flush to the ground level as per the marking book in presence of the Forest Section Officer concerned, felled produce converted and timber and fuel handed over to the section officer as per the marking book. Fuel should be converted and stacked in the stacks of 1M x 1M x 1Mor its multiplies and timber species stacked at convenient stacks duly debarking at mid girth at the cost of the Bhadrachalam Paper Boards Ltd.
- 4. No further widening of the pipe line shall be allowed.
- 5. The labourers or the contractors engaged in this work should not indulge in illicit fellings or damage to the forests with in a radious of half K.M. to the work stop, failling which they will be dealt with suitably under the provisions of the A.P. Forest Act, 1967
- 6. The areas covered by the pipe line will not be disreserved alienated but will continue to be the property of
 Forest Department. The area will however he admitted
 as a right water course under section 17 of the A.P.
 Forest Act, and the authorities of Bhadrachalam Paper

 Boards Limited will be given full freedeom to do all
 acts necessary with in the limits admitted to maintain,
 repair or improve the same without ary hindrance.
