Sub: Permission for laying of water pipeline along the road on NH-34 (Old NH-86) from Km. 109.910 to Km. 111.000 (Right Side) for 150mm, 100mm, 90mm dia water pipeline and Km. 110.216 to Km. 111.000 (Left Side) for 250mm dia water pipeline along NH-34 total length of 1.874 Km. and 04 nos. crossing at Km. 110.216, 112.458, 119.734 and Km. 119.736 in the State of U.P.

Sir,

This is regarding the approval for for laying of underground pipeline along the road on NH-34 (Old NH-86) from Km. 109.910 to Km. 111.000 (Right Side) for 150mm, 100mm, 90mm dia water pipeline and Km. 110.216 to Km. 111.000 (Left Side) for 250mm dia water pipeline along NH-34 total length of 1.874 Km. and 04 nos. crossing at Km. 110.216, 112.458, 119.734 and Km. 119.736 for granting permission in the State of U.P as submitted by you.

2. In view of above, the Competent Authority has conveyed the approval and further Competent Authority has authorized Project Director on behalf of NHAI for signing of License Agreement after the completion of 30 days of application on public domain. The above approval is subject to ensure the compliance of following conditions before according permission:-

- Applicant undertakes that no other structure will be erected nor any other service rendered within the ROW of NH without prior permission of NHAI.
- Applicant will ensure that all safety measures will be taken during execution of works at site.
- If any adverse comments received against the instant NOC, then approved NOC may be treated as cancelled until further clarification/ approval.
- The minimum time period of Bank Guarantee as per Ministry Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 is 01 year. Hence, applicant is required to extend the BG validity date.
- The crossing length has not been considered in calculation of license fees and it is requested to deposit license fee for crossing length & submit the confirmation of license fee deposited in "Bharat Kosh" through online before signing the License Agreement.
- The above approval is subject to ensure the compliance of following conditions before according permission:-
 - The laying work will be done as per the proposed/ agreed location route and as per proposed layout plan.
 - The Licensee shall have to provide the safety measures like barricading danger lighting and other necessary caution boards while executing the work.
 - Appropriate fees be levied for use of NH land for laying of Utilities as per Ministry Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016.

iv. Undertaking to the following effect may be submitted and made part of the agreement:-


- a) Three copies of "As Laid Drawings" of utilities (Hard and Soft copies) shall be submitted to Highway Authorities for verifications and record within a month of completion of works.
- b) The permission may be terminated immediately on violation of the agreed terms and conditions.
- c) The execution of the proposal by the Applicant would not hinder the future widening, if any, at the particular location and if required then the applicant would ensure shifting of their utility at their own cost without any liability to NHAI in a time bound manner prescribed by NHAI.
- d) Ensure that the submitted Agreement is in prescribed format as per Ministry Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 for execution with the applicant, and BG be obtained as per the Circular.
- e) Work programme may be submitted and ensure timely completion.
- f) The compliance of various undertakings given by the Applicant may be ensured before and after signing of License Agreement, as the case may be in the interest of Safety of road users and NHAI.
- (v) Laying work should be carried out through HDD method only.
- (vi) It shall be the responsibility of the Applicant to ensure the Safety and manoeuvrability of Highway Traffic during laying of pipeline.
- (vii) The approval is based on the submissions made by the Applicant as verified by the PD, PIU-Kanpur. The applicant is responsible for details provided in the application. The NHAI is at liberty to verify the authenticity of the documents at any time. Any misrepresentations, omission or suppression of facts or disclosure of incomplete facts detected at any stage shall lead to withdrawal of this approval with cost to the applicant.
- (viii) In view of any future development requiring necessary alteration, including complete removal or shifting of the Pipeline, the same shall be carried out by the applicant at its own cost to the satisfaction the Highway Administrator.
- (ix) In case of violation of the norms of Ministry's Guidelines, the NOC automatically stand withdrawn.
- (x) IRC:98-2011 be complied wherever applicable.

Further, the Bank Guarantee No. 220380IBGP00200 dtd. 12.07.2022 amounting to Rs. 7,50,900/- issued by IDBI Bank valid upto 17.05.2023, if the work is not completed within time, the same shall be extended by the applicant.

In view of above, it is requested to furnish all the above documents/ undertakings at the earliest, so that the agreement for above work may be executed. It is further requested not to start any construction activity before execution of the agreement.


The above agreement will be executed in triplicate on stamp paper of Rs. 100/- and each part to this agreement may retain original with stamped copy.
