महोदय,

उपरोक्त विषय के सम्बन्ध में अवगत कराना है कि उक्त वनभूमि हस्तान्तरण प्रस्ताव भारत सरकार (क्षेत्रीय कार्यालय देहरादून) द्वारा अपने पत्रांक मिस/ II/ROC/COP/2013/1101 दिनांक 25/09/2017 के द्वारा समय से दस्तावेज/सूचनायें उपलब्ध न होने के कारण वन संरक्षण अधिनियम के मार्गदर्शी के पैरा 4.14 के तहत बन्द कर दिया गया। उक्त प्रस्ताव पर भारत सरकार (क्षेत्रीय कार्यालय देहरादून) के पत्रांक 8बी/यू.सी.पी./06/102/2016 के द्वारा लगाई गई आपत्तियों का निराकरण बिन्दुवार निम्नवत कर दिया गया है जो कि पूर्व में इस कार्यालय के पत्रांक 2708/13सी. दिनांक 13.09.2017 के द्वारा आपको प्रेषित किया जा चुका है।

1	In bar chart of proposed road and land schedule uploaded as additional documents in online Part-I and also in the hard copy of the proposal the area proposed for diversion is shown as 0.525 ha. which may be corrected.	Formerly only the area of forest land for Road 750 m long and 7 m wide (0.525 ha) was taken and erroneously 0.087 ha for muck disposal was left.
2	In all the documents in hard copy which also includes Land schedule Bar chart Part-I & Part-II Site Inspection Report of DFO Length and width of road etc. the area proposed for diversion has been mentioned as 0.525. State Govt. may send revised hard copy after correcting the area proposed for diversion as 0.612 ha. after including 0.087 ha. area proposed for muck dumping and also correcting purposewise/component wise break up.	Now all documents of the proposal containing error have been revised for (0.525 ha + 0.087 ha =) 0.612 ha and the revised hard copy has been sent to Nodal office by this office's letter no. 2708/13C dated 13/09/2017 and the corrected documents have been uploaded online at respective Sections in Form A Part-I.
3	In this case 750 m long road is proposed on forest land for which 91 trees are proposed to be felled. State Govt. may explain necessity of the road also indicating whether two villages proposed to be connected with this road are already having road connectivity or not.	This Road is essential need of the villages Bhatwari Sunar and Dubadku (Total 527 people) which are still not connected by a road link. Out of 91 Trees to be felled 68 trees are 10-20 dia. Hence the case may be considered in the public welfare.

6	May provide/upload scanned copy of GIS software generated geo referenced digital map showing geo coordinates at 200 to 300 m interval along the alignment of the proposed road including all turning points (.TIFF,.IMG or .JPEG). Thereafter, this map only may be uploaded as KML file in C (b) Part I.	GIS software generated geo referenced digital map showing geo coordinates at 200 to 300 m interval is uploaded at section C-iv and the KML file uploaded at section C-ii-b in form A Part-I.
7	The area proposed for diversion is 0.612 ha but the area mentioned in FRA certificate and in all but the area mentioned in FRA certificate and all in its annexure is 0.525 ha. The state Govt may correct the area in FRA certificate and in all its annexure and submit/upload revised FRA.	Revised FRA certificate and in all its annexure for 0.612 ha area have been provided and uploaded in section K of form-A, Part-I
8	As mentioned in the land schedule uploaded in part I, as an additional document the area proposed for diversion is "Van panchayat land" but in part II the legal status of forest land shown as revenue forest need necessary correction.	Correction to be made by DFO office
9	The density shown in part II is 0.3 which seems to be incorrect as 146 trees per hectare does not account for 0.3 density. The state Govt may review the density and provide NPV calculation also which is not provided in the proposal.	Correction to be made by DFO office
