

BRIFE NOTE

Subject : **Diversion of 31.33 Hec. of Forest Land for Wdg. of 6-LANING/4-LANING OF KARNAL-MEERUT ROAD (ROAD ID-9812) RD.0.00 TO 14.445 NOW DECLARED AS NH-709A INCLUDED RE-CONSTRUCTION OF BRIDGE AND HL BRIDGE AT RD.2800 & 4900 IN KARNAL DISTRICT (CM ANNC. CODE NO.20093).**
Online Proposal No.FP/HR/ROAD/35434/2018.

In this regard, it is submitted that this office has applied NOC for forest clearance to Forest Department through online proposal No.FP/HR/ROAD/35434/2018 and 12.09.2018 & submit Hard copy of case to D.F.O. (T), Karnal vide T/o memo No.628 dated 09.10.2018 for the work cited as subject.

After that all formalities regarding allotment of tender of this work to early start at site was completed by opening of financial bid on dated 29.08.2019 & tender case submitted to Head office vide S.E. NH Circle, Jind office memo No.W/2138 dated 03.09.2019 in favour of lowest contractual agency i.e. M/s Diamond Construction Co., Kaithal but pending in Head office due to NOC not received so far from Forest Department.

Further, the D.F.O. has raised the observation online on Forest Clearance web portal on dated 25.10.2019 regarding “provide land to forest department as soon as possible”.

Accordingly, the D.D.P.O. Karnal has submitted to this office that the various applications from Gram Panchayat in Karnal District has been received in his office for providing the 117.00 Acre land to Forest Department vide his office letter No.9835 dated 28.11.2019 as directed by the Worthy D.C Karnal in the meeting on dt.19.11.2019 to D.D.P.O. Karnal. After that this office has prepared estimate for Land Acquisition for compensatory afforestation in lieu of diversion of protected forest land for above said work amounting to Rs.63.30 Crore with solatium & submitted to Head office vide S.E. NH Circle, Jind office memo No.W/3041 dated 11.12.2019 but Head office has directed to re-submit estimate without solatium on collector rate vide his office memo No.12-NH-2018/2081 dated 03.01.2020.

In the meantime, the D.D.P.O. Karnal has re-submitted to this office that the various applications from Gram Panchayat in Karnal District has been received in his office for providing the 112.00 Acre land to Forest Department vide his office letter No.10339 dated 19.12.2019 in which the D.D.P.O. Karnal has finalized 102.00 Acres land of 8 Villages as per details given below :-

1)	Village Tikri	-	12 Acres
2)	Village Kurali	-	8 Acres
3)	Village Kunjpura	-	15 Acres
4)	Village Mugal Majra	-	10 Acres
5)	Village Bajida Rodan	-	12 Acres
6)	Village Umarpur	-	25 Acres
7)	Village Gondar	-	10 Acres
8)	Village Uplana	-	10 Acres
Total		=	102 Acres

Accordingly, the revised estimate of land acquisition for compensatory afforestation in lieu of diversion of protected forest land for the above said work is stands submitted to Head office for Rs.45.47 crore without solatium and including 5% registration charges vide S.E. (NH) Circle, Jind office memo No.W/62 dated 08.01.2020.

In view of the above facts, it is submitted that the Forest land payment to be transferred in the name of Forest Department after approval of above said estimate from the competent authority.
