

PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Sub: - Construction of bridges and Impts. of roads under NABARD loan assistance -RIDF-XXIV scheme - Administrative Approval reg.

PREAMBLE:-

Government in its O.M. read at (1) had constituted the Cabinet Sub Committee to consider & prioritise the action plans under RIDF scheme to avail of the loan assistance from NABARD. Government in its letter read at (2) had communicated concurrence to reprioritise 22 roads and 34 bridge projects amounting to Rs. 58.30 crore under RIDF-24, which were posed earlier under RIDF-23. Out of which, NABARD in its letter dated:24-08-2018 had approved 10 road and 28 bridge projects amounting to Rs. 34.77 crore.

NABARD in its letter read at-3, has communicated approval to 8 road & 1 bridge projects amounting to Rs.12.39 crore with a loan assistance of Rs.9.91 crore under RIDF-XXIV tranche. It is also mentioned in NABARD letter that the sanction is accorded subject to obtaining the Administrative Approval within one month from the date of sanction and the detailed sanction letter will be issued after the receipt of Administrative Approval.

Government is pleased to accord Administrative Approval to the 8 road and 1 bridge projects at an estimated amount of Rs.12.39 crore (Rs. Twelve crore and thirty nine lakh only) with a loan assistance of Rs. 9.91 crore as per the Annexure.

All these projects shall be completed before 31st Marsh 2021 as per the phasing of NABARD assistance and the defect liability period for all these projects shall not be less than 2 years.

The expenditure on these projects shall be met under the Head of Account *5054 Capital Outlay on Roads and Bridges-04-337-0-02-436 NABARD Assisted Major District Road Works"
