## Preamble:-

*An Ordinance was promulgated by Government of Karnataka for restructuring of the Power Sector in Karnataka, Corporatization of Karnataka Electricity Board and rationalization of Generation, Transmission, Distribution and Supply of Electricity called Karnataka Electricity Ordinance Reforms, 1999.*

*Consequent to the above said Ordinance the erstwhile Karnataka Electricity Board was corporatized and Karnataka Power Transmission Corporation Limited (KPTCL) was registered as a Company on 28.07.1999 under the Companies Act-1956 and started functioning as a Transmission Company w.e.f 01.08.1999.*

*Further, KPTCL was unbundled and four new independent Distribution Companies called Bangalore Electricity Supply Company (BESCOM), Mangalore Electricity Supply Company (MESCOM), Hubli Electricity Supply Company (HESCOM), Gulbarga Electricity Supply Company (GESCOM) started functioning from 01.06.2002. Later on another distribution Company was carved out of MESCOM called as Chamundeshwari Electricity Supply Company (CESC) and it is started functioning from 01.04.2005.*

*The erstwhile Karnataka Electricity Board had framed Regulations for smooth functioning of its activities and had the published various manuals from 1987 to 1999 duly incorporating the amendments as on that date.*



*Over the years, keeping in pace with the reforms in the Power Sector, various amendments have been issued and Regulations have been framed.*

Govt. of Karnataka vide Notification No. DPAR 12 SRC 2019, Bengaluru dated: 07.01.2021 issued Karnataka State Civil Services (Conduct) Rules, 2021.

*Board of Directors of KPTCL at its 124<sup>th</sup> Meeting held on 09.04.2021 approved renaming the existing KEB Regulations and Manuals as KPTCL's Regulations and Manuals. Further it was resolved to adopt Karnataka State Civil Services (Conduct) Rules, 2021 mutatis mutandis in KPTCL as annexed to this order as KPTCL Employees Service (Conduct) Regulations, 2021.*

Hence the following Order:

The existing KEB Employees (Conduct) Regulations in this regard are repealed provided that such repeal shall not affect the previous operation of the said rules or anything duly done or suffered thereunder or affect any right, liability or obligation acquired, accrued or incurred under the said Rules.

"The aforesaid Regulations/Rules/Manuals shall come into force w.e.f., the date of 124<sup>th</sup> Meeting of Board of Directors viz. 09<sup>th</sup> April 2021"

The Regulations/Manuals as approved shall be published accordingly.
