The General Manger, Vindhya Telelinks Limited, Secunderabad, Telangana has submitted that they are laying underground Optical Fiber Cable(OFC) from within the existing Right of way of 1) Kambojipet village limits, Chennur(M), lengh-2391 mtrs, Area 0.0956 Ha, under Chennur Forest Division, 2) Bheemaram village, Bheemaram(M), lengh-2132 Mtrd Area-0.0853 Ha passing through forest under Mancherial Forest Division in Mancherial District and further stated that they have submitted Online application in PARIVESH Portal vide proposal cited and the same is under Field Inspection by DFO, Chennur Division and requested to issue Form-1 (Linear projects) duly certifying by the District Collector.

In this regard, the Revenue Divisional Officer, Mancherial has submitted that the Tahsildar, Bheemaram and Chennur have inspected the forest land with the concern forest officials and submitted the A to H certificates and the Gramasabhas were conducted & Unanimously passed resolution under the chairmanship of Sarpanchas and Panchayat secretaries Bheemaram village of Bheemaram Mandal and Kabojipet village of Chennur Mandal and stated that, there is no encroachments by the tribal people in the proposed forest land to be diverted and further resolved that there is no pending RoFR claims to be settled under the Forest Right Act and No RoFR's pattas issued in said proposed forest area.

Further the Revenue Divisional Officer, Mancherial has submitted that based on the resolution passed by the Gram Panchayats in Grama Sabhas, the members of the Sub District level Committee, Mancherial have given no objection regarding the diversion of forest land i.e., 1) Kambojipet village limits, Chennur(M), lengh-2391 mtrs, Area 0.0956 Ha, under Chennur Forest Division, 2) Bheemaram village, Bheemaram(M), lengh-2132 Mtrd Area-0.0853 Ha passing through forest under Mancherial Forest Division for laying underground Optical Fiber Cable(OFC) in Mancherial District.

Further the Tahsildar's Bheemaram and Chennur have certified that there is "no RoFR patta rights certificate were issued under RoFR Act, there are no pending RoFR claims to be settled under the Forest Rights Act and no RoFR encroachments existing in the limits of the proposed forest division area.

Basing on the resolutions passed by the Gram Panchayath of Bheemaram village of Bheemaram Mandal and Kambojipet of Chennur Mandal in Grama Sabha, certification of the Tahsildar's, Bheemaram and Chennur and the no objection given by the Sub-District Level Committee, Mancherial, the District level committee, Mancherial has no objection regarding the diversion of forest land to an extent of **0.0956** Ha in Chennur forest division and **0.0853** Ha in Mancherial forest division of Mancherial District "for laying underground Optical Fiber Cable(OFC)" in Mancherial District in favour of the General Manger, Vindhya Telelinks Limited, Secunderabad, Telangana and subsequent issue of certificate in Form-I.
