Kindly refer to Nodal Officer-cum-APCCF (FCA) O/o Pr.CCF (HoFF) HP letter No. Ft.48/3559/2017 (FCA) dated 19.11.2024 whereby following observations (EDS) raised and reply of the same is furnished as under :-

Sr. No.	Observation	Reply/Compliance
1.	The reply of observation No. 4 still not correct, the proposed diversion area (DA) is still 5.4326 ha. further, the Tunnel and adit tunnel is marked over the house which need rectification/correction.	The User Agency sent reply to corresponding observation that proposed diversion area (DA) has been corrected. The proposed diversion area (4.9069) Ha. is shown in green colour and Private Area is shown in yellow colour. Further the Tunnel and the Adit Tunnel that were marked over the house have been corrected and the revised KML file with correct area figure has been uploaded in PARIVESH 1.0 Portal also.
2.	As per DSS analysis, out of the 10 ha. proposed CA area, 1.54 falls in very Dense forest and 4.1 Ha. falls under MDF, same may be reviewed and rectified/replaced with the other CA area with density less than 0.4.	In this regard undersigned got the CA sites reviewed/re-inspected through field functionary and User Agency on 13.12.2024 and it has been transpired that Compensatory afforestation area to the extent of 10 Ha. falls in UPF Bharahatu, Urla Block, Urla Range there exists Barberries Shrubs and bushes abundantly in the selected CA site due to which in DSS analysis is appears very dense and MDF in some parts. However, the selected CA land in DPF Bharahatu have scattered trees and degraded forest land, which is suitable and fit for plantation. The necessary CA Suitability Certificate duly attested by RFO, UA and undersigned enclosed herewith as per Annexure-1

It is, therefore requested that the necessary Stage-II approval for the diversion of above land may kindly be obtained from competent authority please..


