I invite attention to the references cited, wherein the Superintending Engineer, PR Circle, Visakhapatnam has submitted proposals in the reference 5th cited covering all earlier proposals stated that the Inspector General of Forest Integrated Regional Office, Vijayawada has informed that as per para 4.4 of the Comprehensive guidelines related to General approval for public infrastructure projects in LWE district has expired on 31.12.2020 and as per the latest forest guidelines implied from 01-01-2021 for road works for which forest area is greater than 1 Ha, Compensatory Afforestation land (CA land) is to be handed over to the forest department for the diversion of forest land. As per the revised guidelines additional CA land is required for the following list of works tabulated below:

He requested to issue necessary instructions to the concerned authorities for identifying CA land for the above said works to an extent nearly 55.00 Ha in addition for diversion of Forest land to handover the same to the Forest department for further process of forest clearance and for speedy execution of sanctioned road works.

The Superintending Engineer, PR Circle, Visakhapatnam has stated that the Tahsildar, Koyyuru identified for an extent of land 9.10 Ha in Kantaram village for Compensatory Afforestation purpose and the DGPS survey was completed. The Sub-Collector, Narsipatnam

has informed that an extent of Ac.50.00 cts (20.23 Ha) un-surveyed land is available in Sarugudu village of Nathayaram Mandal for Compensatory Afforestation purpose.

He further stated that the Revenue Divisional Officer, Paderu has informed that an extent of Ac.66.94 cts (27.09 Ha) land is available in S.No.48p in Kommika village of Koyyuru Mandal for Compensatory Afforestation purpose and the DGPS survey was also completed and he requested to issue necessary instructions to the Tahsildar, Koyyuru and Nathavaram mandals to process alienation proposals for the following works, Meanwhile the Revenue Divisional Officer, Paderu reported that the Tahsildar, Paderu has identified the Government land for an extent of Ac.135.90 cts (55.00 Hectors) of S.Boddaputtu village of Iradapalli Panchayat of Paderu Mandal and the proposed land is classified as 'Konda Poramboke' and suitable for Compensatory Afforestation.

I therefore request that conduct joint inspection along with the Forest officials for suitability of identified CA land and also submit alienation proposals for Compensatory Afforestation to take further action in the matter. Necessary copies are herewith enclosed.
