The preliminary estimate received with your reply has not been found uploaded in the PARIVESH portal.	The estimated cost has now been revised and uploaded on the parivesh portal for ready reference.
2.	No specific justification has not been furnished in the reply for not uploading the administrative approval. The earlier justification uploaded as additional information at Sr No. 17 of Part-I for not providing the administrative approval was not accepted by Nodal Officer -cum-APCCF (FCA) Shimla	A copy of Administrative Approval has been obtained and uploaded on the Parivesh portal for ready reference.

Subsequently, after detailed technical examination, a Preliminary Estimate amounting to Rs 519.75 lakh was prepared by the Department. Thereafter, on the basis of revised scope and current Schedule of Rates, the project cost was further revised, and a revised estimate of Rs 626.38 lakh was finalized. It is further certified that the Administrative Approval (A/A) for Rs 626.38 lakh (Rupees Six Crore Twenty Six Lakh Thirty Eight Thousand only) has been accorded by the Government of Himachal Pradesh, Public Works Department, vide letter No.PWD-B-F0(5)/73/2025-312830 dated 08.01.2026. Accordingly, it is clarified that the earlier estimated cost Rs475.00 lakh and Rs 571.75 lakh stand superseded, and the approved and operative project cost is RS 626.38 lakh.
