1. Certificate of justification has been uploaded on Parivesh Portal and will be made available once the proposal is resubmitted.
2. As the road has been constructed long back and taken over by this division recently under upgradation, hence the details of the proposal seeking prior approval has not been filled and kept as "Nil" according to the Form -A, as no forest clearance has been submitted in the past years.
3. No FCA Sanction order of the projected road exists.



Sir,

Appros to the above cited subject it is to submit that the road project is sanctioned by MORD(GOI) under PMGSY-II. As the road is approved under upgradation, the population of the targeted habitations gets directly benefitted. Also, the road passes through forest area for length of around 1.5kms from Lillam to Waisa village having 11000 souls approximately and hence cannot be avoided as the existing alignment needs to be upgraded providing all weather connectivity to the hamlets.

In this connection, it is requested to kindly provide clearance regarding the settlement of The Scheduled Tribes & other Traditional Forest Dwellers (Recognition of Forest Rights Act, 2006) to recognise & vest the forest rights & occupation of forest Dwellers, who have been residing in such forest for generations, if any.
