Subject : No Objection Certificate for development of proposed retailed outlet of Hindustan Petroleum Corporation Ltd. at Khewat No. 166/155 Khatoni No. 188, Khasra No. 65/21/1 at Chainage 12.30 (RHS) centre of plot at Village Mattan, Tehsil Bahadurgarh in Jhajjar District.


Reference : Your office memo No. 3258-63/ PLB Dated 24/12/2016.

In accordance with the plan submitted by you vide letter under reference showing the proposed Retail Outlet / Petrol Pump the abutting on **Bahadurgarh – Chhara Road (MDR -122), in Plot with Khewat No. 166/155 Khatoni No. 188, Khasra No. 65/2/1 at Chainage 12.30 (RHS) centre of plot at Village Mattan, Tehsil Bahadurgarh in Jhajjar District.** Accordingly provisional NOC is hereby accorded for one year subject to the following condition:

1. That there will be no violation of any of the provision/clause contained in the Punjab Schedule Road and Controlled Area Restriction of Unregulated Development Act 1963 or as amended by time to time.
2. That cross drainage 1.0 m dia hume pipe culvert will be provided by you at your own cost.
3. That no pucca construction is allowed within 30 Mtr. Parallel to PWD boundary, construction made if any, may be dismantled immediately. Any violation in this respect will automatically result to termination of NOC.
4. That the access / approach road should be constructed at least 0.15 mtr. Lower than the PWD road level with onward slope from the edge of PWD road.
5. That one speed breaker on the access / approach road shall be provided at a suitable distance from metalled edge of PWD road.
6. That the approach road constructed in the PWD land will be the property of PWD department but shall be maintained by the owner of property. The PWD Department shall have the right to remove the access/approach road without any notice.
7. That the access/ approach road/ service road and drainage systems shall be constructed strictly in accordance with the drawings after consulting and under the supervision of the Sub Divisional Engineer, Provincial Sub Division No. II, PWD B&R Branch, Bahadurgarh. In case any deviation is found from the drawings at any stage the NOC / License shall be liable to cancelled.
8. That the take off point shall be improved according to the land available to avoid accident.
9. That there should be no encroachment on PWD land in shape of fencing or boundary wall etc.

10. That separate NOC shall be obtained by you from Forest Department Town & Country Planning, UHBVN, Fire Department S.D.O. (Civil) Police Department before starting the service lane.
11. The license hereby granted shall not be transferable.
12. That no material will be dumped by the owner on PWD.Land.
13. This permission does not provide immunity to any of the provisions of any other act/ rules applicable in this area.
14. In future, if road authority consider it necessary to remove the approach road for widening purpose or repair to the road, the same will be carried out at your own cost.
15. The company/ owner has deposited a sum of Rs.65000/- lease and process fess vide charges D.D.231444 dated 22/03/2017 valid for fifteen years from the issued of this letter i.e. upto 22/03/2031 after which the license / NOC will be get re-validate after depositing the lease charges prevailing at that time.
