	(iv) Justification for locating the project in forest area	<p>This Scheme has been designed to cover 102 No partially Covered (PC) Habitation of 69 No census villages under 14 No Gram Panchayat having present Population of 13282 person, design period of 20 years and ultimate population of 16622 persons. The Ultimate water requirement worked out to be 1163450 litre per day. The proposed source of scheme is Panjondi Nallah which falls in Chuhar valley. The source is snow fed and having lean period discharge of 198.90 LPS, thus source is very reliable and dependable. The scheme is proposed to augment 27 No existing schemes which experiences spell of drought during summer and discharge available reduces to less than 0.5 LPS in these schemes, therefore during drought season, the crises worsens as deployment of tankers are restricted by non-availability of roads.</p> <p>The present status of scheme is that about 80% work such as WTP, Distribution System etc. has already been completed, MSERW Pipes 150mm dia from Uhal River to WTP has been laid but 200mm/150mm dia MSERW pipes from Source to Uhal river could not be laid for the want of forest clearance, although the pipes has been has been procured. The total expenditure to the tune of 10.5 Crore has been already incurred. Therefore, the execution of the project is very important to utilise the expenditure. The proposal is very economical being a gravity scheme and operation & maintainance is negligible as compared to lift schemes where energy charges are high and recurring every year. The water quality of source is very good and it is just like mineral water. Therefore the project is totally</p>
	(v) cost-benefit analysis	Not required as the area of diversion of forest land is less than 5 hac.
	(vi) Employment likely to be generated	However the construction of the road will be done by "A" Class contractor by using mechanical equipment, yet employment of local people will be given as per policy of HP Govt. as such by taking 30% of the total cost 1240 lacs for employment generation minimum employment generation will be 248000 mandays. More important is that by construction of this road the people of this area will get self employment by growing cash crops like foods & vegetables which will boost up their economy.

2	2. Purpose-wise break up of the total land required:	0.8295 hect. Forest land is required for construction of Providing/ Aug. of WSS to PC Habitation of Census Village Footakhal, Hiun, Pundal, etc. in GP Jilhan, Gwali, & Siun etc (Muhaj Panjod, Graman, Kharyan, Dhamchyan, Chelang in Tehsil Padhar Distt.
