The non-forest CA lands are mostly boulders with rocky patches of hillocks in nature, having moderate standing growth of vegetation of mostly miscellaneous species. There is no good natural regeneration in the CA areas. The soil is of mostly red morram. As the areas are isolated with a small patches, with lot of biotic pressure from adjoining villages and there is every possibility of encroachment of these lands for agriculture or for quarry. Hence suitable protection measures are needed from biotic pressure and encroachment by way of protection wall or chain link fence. The identified CA areas are hill areas and rockey patches and also having Misc. bush growth.

Further it is submitted that the Dist. Collector / 1st Class Magistrate, Bhadradri Kothagudem has allotted revenue land for the diversion of Forest land under SRLIP at Puligundala village Sy.No.1/1 of Charla mandal is 20.040 Ha.(49.52 Acrs) vide Dist.Collector Rc.No.E/301/2016,dt.16.08.2017. Where as in this particular Sy.No.1/1 of Puligundala village is having 57.17 Acrs. or 23.136 Ha, Out of which the CA area is allotted to Forest Department under various projects details as follows.


