

With reference to the above cited Subject, you have applied the proposal vide FP/KA/OFC/155716/2022 for diversion of 0.5569 ha of Forest land for laying JIO Optical Fibre Cable along the Right way in NH-PWD road from Krishnanagara-Bannihatti, Rajapura-Bannihatti & Ramadurga-Appayinahalli in Bellay and Vijayanagara Forests Division of Sandur & Kudligi Taluks in Bellary & Vijayanagara Districts.

Your Proposal has been inspected and many defects have been found in Parivessh-1 and now it is suggested to apply in Parivesh-2.0 with the following Changes.

- a) Division: Add Vijayanagara division, also as the division where diversion is taking place.
- b) Forest land required in Vijayanagara Division (Gudekote Range) as per ACF report is (1) Sanduru Taluku, Choranur Sy no:578, length 1900.00 m, Width 0.30 m and extent is 0.057 ha (2) Kudligi Range, Appenahalli Sy.no:01, length 853 m, width 0.30 m and extent is 0.0256 ha.
- c) Forest survey numbers in Choranur & Appenahalli need correction.
- d) Exact location of area required for diversion is not specified. It can be stated for example like 30 cm width at a distance of 10 cm from the edge of the asphalt road etc
- e) Topo sheet indicating boundary of forest land to be diverted is not clear.
- f) Accurate village maps of 1:7920 scale need to be provided for both villages.
