Proposal for Construction of Police Post Sainj, PS Kumarsain District Shimla.

<u>JUSTIFICATION</u>

Diversion of Khasra No. 781/710/1 measuring 00-12-00 Hectare of forest land in favour of Himachal Pradesh Police Department, for the establishment of Police Post Sainj PS Kumarsain Distt. Shimla, within the jurisdiction of Kotgarh Forest Division, Distt. Shimla, HP Proposal No. (FP/HP/Others/15309/2022).

- 1. It is submitted that Police Post Sainj is functioning in private building hired from Rakesh Mehata since 2017 vide. Letter No. Home (A) B(1)12/2014 dated 21-09-2017 read with PHQ letter No. P-II (1) Shimla / 97-26479-35 dated 28-09-2017. The Police Post is situated at a distance of 75 KM from District Headquarter and 22 KM and 08 Gram Panchayat and 34 villages' falls under the jurisdiction of this Police Post.
- 2. For the construction of Police Post Sainj building, District Shimla, Police Department had made liaison with the local public as well as panchayat authorities for finding the suitable non-forest land. However, they refused to donate and sale the land to Police Department for the reason due to shortage of private land.
- 3. That in view of notification Ft. 29-241/B/C49 dated 25.02.1952 issued by the Government of Himachal Pradesh according to which all Govt. waste land has been declared as protected forests and as such, Department has found one piece of Govt. land having Khasra No. 781/710/1 at Mohal Sanj parnu measuring 0-12-00 Hectare for the construction of Police Post Sanj.
- 4. That it is further submitted that joint inspection has been conducted by a committee headed by Naib Tehsildar, Sub-Tehsil Kotgarh, District Shimla, HP consisting Police Department, PWD Department, Revenue Department, and has proposed Govt. land having Khasra No. 781/710/1 at Mohal Sanj parnu measuring 0-12-00 Hectare for the construction of Police Post Sanj in larger public interest.
- 5. That the above proposed/selected site/land, are having Khasra No. 781/710/1 at Mohal Sanj parnu measuring 0-12-00 Hectare deemed highly suitable for the construction of Police Post Sanj in larger public interest as the location is just adjoining to National Highway-05, centrally located for all Panchayats as such, there would be effective management of law and order, traffic management, drug menace and other important factors from the site/lands. Further, construction of Police Post just adjoining to National Highway would save the reaction time of Police functionary to act in accordance with law in critical situations, from this particular site. Further,

these sites land are having lesser trees, not any natural water resources, common path these sites and cremation ground etc. Moreover, the sites/lands are having better connectivity of

That apart from the proposed sites/lands i.e Govt. land having Khasra No. 781/710/1 Mohal Sanj parnu measuring 0-12-00 Hectare there is no other suitable non-forest alternate site available in the area for the construction of Police Post. Moreover. The Deputy Commissioner Shimla on dated 10-10-2017 has issued non-Availability Certificate of non-forest land

Keeping in view of above narrated facts and circumstances, the proposed site/lands i.e. Govt. land having Khasra No. 781/710/1 Mohal Sainj measuring 0-12-00 Hectare are the most strategic location to establish the Police Post Sainj, District Shimla in larger public interest.
