1) **Project Details: -**

- i) Short narrative of the proposal and project/ scheme for which the forest land is required :: It is observed that there are good quantities of deposits for extraction of Crushed metal stone materials in order to cater the needs of constructions taken up by the Government projects and the private parties in the vicinity and their details are as follows.

- 1) The State Government has planned to construct good number of house
- 2) Expansion of State Roads about 10 Kms distance
- 3) Expansion of NH 18 four lines road Kurnool to Nandyal
- 4) There is a lot of construction activities of large number of houses
- 5) Formation of feeder canals and channels, by the Irrigation Department

It is submitted that there is acute shortage of raw materials like crushed stones and boulders in the RCC constructions of the above projects as the construction activities are under progress. There projects are requiring huge quantities of raw materials like crushed metal stone and boulders. The projects are mainly dependent on such raw materials which are abundantly available in the area.

It is proposed to extract the deposits, in an effective manner, with machinery and other sophisticated methods to cater to the needs for heavy construction activities. The present operations are not keeping pace with the demand resulting bottle necks in the construction activities of Government in particulars and private construction in general. The projects ensures not only environmental protection by raising forest species in other alternative areas and also generate employment to the local youth and weaker sections of people.

- ii) Map showing the required forest land, boundary of adjoining forest on a 1:50,000 scale map. :: The area applied for the quarry lease is 3.960 Ha. located in Bhanumukala (V) in Compt.No.313 of G.A.Bad South Block of Banaganapalli Section of Dhone Range, Kurnool Forest Division in Kurnool District. Map showing the location of forest area including approach road is herewith enclosed.
- iii) Cost of the Project :: The initial investment is Rs.65.00 lakhs and it is likely to be increased due to provisions of mechanical equipment etc.
- iv) Justification for locating the project in forest area :: There are stony deposits abundantly available in the area applied for. The material is unique in nature with potentiality, strength and it is most useful for masonry in RCC constructions. similar deposits are not available in the other areas nearby and only available in the area applied for, lack of vegetation in the area applied for one of the main reasons, so as not to get the tree growth felled to affect ecological problems. The entire area is rocky, hard and fit for excavation of stone deposits. The area proposed in Kurnool District and it is situated in remote area of Rayalaseema area where there is no

development. The unit is proposed for providing sufficient employment to the local unemployed youth and other downtrodden people. At present there are no units to extract metal stone in the vicinity of RF.
