ORDER:

In his representation first read above the Trustee, Vipashyana International Meditation Centre, Kusumnagar, Hyderabad has stated, that the Meditation Centre has been established on Mr. Mehata's land at Kusumnagar situated at 12/6 K.M. on Nagarjuna-sagar Road, that the Meditation centre is being passage of 45' to 60' wide from the main road to Ashram, and requested that the Meditation centre may be permitted to form a pucca motorable road at the cost of Meditation centre. In his letter second read above, the Chief Conservator of Forests has stated that the request of the Meditation centre may be rejected in the interest of the existing eucalyptus and cashew plantations.

2. The Government have examined the matter and consider that there should be no objection to accede to the request of the Centre, subject to the following conditions:-

- (1) that the way to be permitted should be used only for the Meditation centre;
- (2) that the Meditation centre will put up barbed wire fencing all along, on both sides in the forest area, so that, the forest will remain protected; and
- (3) that this permission to pass through the forest area will be withdrawn, if the centre is used for any other purpose or sold at a later date.

3. The Government accordingly direct that the Vipashyana International Meditation Centre, Kusumnagar, Hyderabad be permitted to use the passage of 60' through the Gurrum forest Block subject to the conditions specified in para 2 above.

4. The Chief Conservator of Forests is requested to take necessary action in the matter, ~~in the matter of~~.
