## PROFILE OF THE USER AGENCY






## DETAILED NOTE ON THE PROJECT


The road from Ravulapally- Maddur in Telangana State is an important Major District road. Now the works (i) Widening and Strengthening of Ravulapally - Maddur road from km 0/0 to 4/0 and 7/2 to 14/0 in Mahabubnagar District and (ii) Widening and Strengthening of Ravulapally - Maddur road from km 4/0 to 7/2 in Mahabubnagar District sanctioned by the Government vide G.O.Rt.No.318, T.(R&B) R.III Dept. Dt.26.02.2014 for Rs.900.00 Lakhs and G.O.Rt.No.261, T.(R&B) R.III Dept. Dt.19.02.2014 for Rs.210.00 Lakhs the works are entrusted to the agency for execution.


Widening and improvement of this Road would further improve the connectivity in terms of achieving smooth and safe traffic flow and improve level of service. In addition to above, substantial economic gain in terms of reduced Vehicle Operating Cost (VOC) and reduced travel time will be achieved.

The reach from Km.3/2 to 4/2(1km) which passes through reserve forest area of Doulthabad reserve forest. The existing formation width of the road is 7.00 m which is insufficient to cater the need of the heavy vehicular traffic. As such it is proposed to widen the road. The total area of widening is worked out to 0.335 Ha.


## CERTIFICATE FOR BARE MINIMUM


CERTIFICATE FOR PAYMENT OF NET PRESENT VALUE


